

2019 NJHFR STALLING INFORMATION



Each contestant entering in an NJHFR timed event will be allowed ONE STALL PER EVENT.

Rough Stock Contestants, Shooting Sports Contestants or Contestants who have not qualified in an event (Student Officer Candidates) will NOT be issued stalls unless they qualify in another timed event or wish to pay the price for an “extra stall”. Extra stalls will be issued on a first come, first served basis only after registered contestant horses are stalled.

Any available extra stalls will be \$245. Location of these stalls is not guaranteed.

PLEASE READ THROUGH THE CHECK- IN PROCEDURE AND STALL RULES DURING THE EVENT BELOW

CHECK-IN PROCEDURE:

- **Horse check-in will be open 24 hours beginning at 12:00 noon on Thursday, June 20th until 7:00am, Sunday June 23rd, 2019. ALL HORSES AND CAMPERS MUST BE CHECKED IN BY 6:00PM SUNDAY, JUNE 23rd, 2019. CONTESTANTS MUST BE CHECKED IN BY 7:00AM ON SUNDAY.**
- **In the event of a late arrival, contact the Rodeo Office at 605-353-6650.**
- **Any/All horse(s) at the South Dakota State Fairgrounds MUST BE CHECKED IN THROUGH HORSE CHECK-IN AND BE STALLED ON GROUNDS.**
- Have all horse papers available at check-in, including Coggins (within 12 months of the event), and Health Inspection (within 30 days of the event) and Brand Inspection (if you are from a Brand State). It is important that you make copies for yourself before you leave home.
- If you are leasing a horse, the contestant is responsible for informing the horse owner of the required check-in paperwork. A leased horse will not be checked in without the above paperwork. LEASED HORSES MUST ALSO BE STALLED ON GROUNDS.
- **STUDS WILL BE STALLED IN STALLS RESERVED FOR STUD HORSES.**
- Horses may not be ridden or walked in the Campsites, parking lots, the medical area, the recreation areas, the tradeshow area, pedestrian areas OR IN ANY STALLING BARN.
- **ALL HOOVED ANIMALS BROUGHT ON THE GROUNDS MUST BE IN A STALL ON THE GROUNDS- THIS INCLUDES GOATS.** Goats brought on grounds **MUST** have valid Health Inspection papers.

DURING THE EVENT:

- PLEASE PARK HORSE TRAILERS IN THE DESIGNATED AREAS. Parking staff will help you find the appropriate place. Non-living quarters trailers WILL NOT be allowed in the campgrounds.
- Stalls will be monitored at all times by the event staff.
- The following barn rules will be enforced for any barn on grounds:
 - Barn Rules
 - Do not wash animals or tack in any barn. Water hoses in any barn is prohibited! Please use wash racks outside the barns
 - DO NOT leave hoses running or blocking alleyways! Water will pool in the lowest point and can flood “downstream” stalls!
 - Heaters and fires are prohibited in the barns
 - NO GOLF CARTS IN THE BARN!
 - Signs in barns are prohibited unless approved by NHSRA Personnel.
 - Keep Stalls Clean and use designated manure pit at the end of each barn
 - **NO SMOKING IN BARN**
 - *Please DO NOT block any entrance or exit in any of the barns*
 - *Electrical Cords are prohibited across the aisles/walkways*
 - *Do not tie horses to the faucets.*
 - **DO NOT DEFACE, MARK OR REMOVE ANY PORTION OF THE STALL. YOU/YOUR STATE WILL BE CHARGED FOR ANY ALTERATIONS AND STALLS WILL BE CHECKED ON A DAILY BASIS.**
 - **ANY ALTERATION (including removing screws to lower panel walls) THAT IS “FIXED” LATER HAS TO BE APPROVED BY THE STALL MANAGER BEFORE CHARGES WILL BE WAIVED!!**
 - **PADLOCKS ON STALLS ARE NOT PERMITTED.**
 - **IF A HORSE IS FOUND IN THE WRONG STALL IT WILL BE REMOVED BY STAFF.**

CHECKOUT:
