

STALLING INFO

Stall Policies:

Each contestant entering the timed events or the queen contest will be allowed only one stall per event. Steer wrestlers and cutters will be allowed two stalls each. **ABSOLUTELY NO STALLS** will be allowed for tack. You will be assigned stalls by state/province/county team as much as possible.

Before you leave home:

- Get current Coggins & Health Papers on each horse. You **MUST** have current paperwork to check-in. Health Inspection is also required for Goats.
- Complete a Horse Identification Paper for each horse. Reference contestant's name and state/province/country team on **ALL** paperwork.
- Check with your local veterinarian on travel and quarantine status for infectious diseases such as West Nile Virus before you leave home.
- Leased horses must have the same current paperwork and it is up to the contestant to inform the
 horse owner of the requirements. Horse owners must bring paperwork with the horse to checkin. Reference contestant's name and qualifying state on all paperwork. Looking for a local horse
 to borrow/lease? Ask to join the Facebook group "NHSFR Lincoln Horse Lease & Loan" set
 up by Lancaster Event Center.
- Brand inspections are NOT required by Nebraska State Law, but may be by other states while traveling.

Check-in Procedures in Lincoln:

- Contestant, Horse & Campground Check-in will begin at 12pm (noon) on Thursday, July 16th and will operate 24 hours a day until 7am Sunday, July 19th. No early check-ins will be allowed.
- After Contestant & Campground Check-in end at 7 am Sunday, only Horse Check-in continues through 6 pm Sunday. All horses MUST be checked in by 6pm Sunday, July 19th.
- All horses, including leased horses, entering the Lancaster Event Center fairgrounds must start through check-in at Gate 2 on Havelock Avenue during above days/hours.
- Only Studs are placed in stud stalls. Studs will be in the Pavilion 2 building.
- During horse check-in, contestants will need to unload their horses, take their horse paperwork and lead their horses to the check-in area and then on to their assigned stall.
- There will be trailer clean-out area available right in the same parking lot where the horses are removed. After clean-out, another person besides the contestant going through horse check-in will need to drive the vehicle with the trailer to the empty horse trailer parking, or take living quarters trailers to the assigned campground, and wait for the contestant to get there. You will get grounds maps upon check-in and you'll find the grounds are very walkable and we will have lots of folks to give directions.

- Horses are only allowed in the stall and arena areas and there will be a designated path between the stalling area and the main outdoor performance arenas.
- Absolutely NO HORSES OR GOATS are permitted in the campgrounds, in parking lots, on the adjacent hiking/biking trail or anywhere outside of the arena and stalling areas.
- Warmup spaces and times will be posted upon your arrival.
- Do not wash horses or tack in your stalls whether in Pavilion 2 or in outdoor stalls. Please use the wash racks located inside Pavilion 2 and outdoors.
- Do not tie horses up to any water faucets, fences, signs, buildings (other than wash rack areas) or trees--inside or outside.
- Please keep your stall area cleaned out and haul manure to designated dump areas.

Check-Out Procedures:

- Horses will not need to check-out before leaving the Lancaster Event Center.
- *Damages/Alterations: ANY alterations to a rented stall will be charged to you as a minimum \$100 damage fee by NHSRA after NHSFR move-out.
